Every day, there are 3-4 babies abandoned on the streets of Johannesburg. Your investment could be the lifeline they so desperately need.

Impact Africa Baby Rescue exists to prevent baby abandonment and unite little ones with their forever family through adoption. Weekly educational campaigns for pregnant women at the clinics in the impoverished areas around Johannesburg are helping thousands of women understand there are alternatives to abandoning their babies as well as counsel and care for those in tumultuous situations.

As a last resort, when a mother feels she has no other alternative than to abandon her baby, we have baby safes set up where a child can be placed safely and anonymously. The baby is then cared for at one of our three baby homes until adopted.

For years, Impact Africa has been meeting the spiritual and practical needs of those living in some of the most desperate and difficult areas of South Africa. We do this through education, sharing the Gospel Message, student assemblies, children's programs, after-school bible club and other various outreach endeavors.

Since conception we have developed in these communities 5 schools, feeding, and educating over 700 students, 3 Baby Homes caring for the abandoned and promoting adoption, a high-school program helping teens weekly and annually we facilitate hundreds of short-term team participants in sharing the Gospel with the people of South Africa.

As a result, we are seeing transformation of lives and Communities on a massive scale!

Impact Kids reaches and educates underprivileged, orphaned, and at-risk children with quality, caring Christian education. Throughout all 5 schools, we are daily educating 725+ students and serve over 7,500 meals per week.

Impact Students strives to engage, equip, and energize public high school students to develop and fulfill their leadership potential. This is imperative as these young students are in the midst of an education crisis where only 30% of students who begin 1st grade actually complete 12th grade. We actively engage with high school students through teaching in government schools, short-term outreach trips (Africans reaching Africans with the Gospel), leadership retreats, and one-on-one life coaching.

This is the right option to repurpose and maximize your deduction without affecting your liquidity. When you decide to make a gift of stock, you will retain your cash assets and receive a charitable tax deduction for the full fair market value of the stock you have owned for a long period of time.
